

Welcome to our first Employer Newsletter for 2011. We are celebrating our 40th birthday this year having started in 1971 as the Catholic Superannuation Fund (CSF) which covered staff in Catholic education across Victoria. At the close of 1971 we had 137 participating employers and a membership of 648 with accumulated funds of around \$368,600.

In July 1995 members of the Archdiocese of Hobart Superannuation Fund transferred into CSF when their fund closed. By then, our membership had grown to over 21,000 with more than 800 participating employers and funds under management (FUM) of over \$500,000,000.

The Catholic Employees (NT) Superannuation Fund was terminated mid-2000 and the members were transferred into CSF. At that time membership had passed 28,000 with more than 1,100 employers and FUM of over \$1 billion.

In November 2005 CSF became a Public Offer Fund which meant membership was open to everyone. CSF became known as Catholic Super in 2007.

As a result of our continued growth and the merger of the National Catholic Superannuation Fund with Catholic Super last year, our funds under management have now surpassed \$4 billion. We have around 70,000 members and 6,000 participating employers.

We are looking forward to continuing our growth over the next 40 years and beyond, and hope that you will be part of that journey with us.



Paying Contributions - notice of NAB account closure

We recently reviewed Catholic Super's banking arrangements and decided to close the old National Catholic Super Fund (NCSF) bank account which was held with National Australia Bank to take effect from 31 January 2011.

We ask that all employers who have been paying into the National Australia Bank account now deposit their contributions into the Catholic Super bank account, details of which are:

We would also like to remind employers who make their cheques payable to "National Catholic Super Fund" to make their cheques payable to "Catholic Super" as the account is now closed and unable to accept cheques payable to NCSF.

- Manage your employees: add new ones, remove and update their details
- Submit your contributions quickly and easily online
- Track your contributions and view historical information
- Manage your employer details.

Some Employers have called us to find out if they should have an Employer ID as well as a User ID to log on to Employer Online.

The same ID applies to both of these fields. Use your Employer number both times as shown in the example to the right.
